BOARD OF COUNTY COMMISSIONERS PROCEEDINGS

AUGUST 29, 2022

The Board of County Commissioners met in regular session at the Douglas County Public Services Building in East Wenatchee, Washington. Commissioners Straub, Sutton, Steinburg, and the Clerk of the Board Tiana Rowland were present. County Administrators County Administrators James Barker, and Jordyn Giulio, as well as Civil Prosecuting Attorney James Mitchell in attendance.

- I. 08:29 AM Pledge of Allegiance and Call to Order.
- II. 08:30 AM Public Comments.
- A. No public present and no written comments were received.

III. 08:31 AM The Board Met with Senator Brad Hawkins.

- A. Introduction of the concept of developing a regional aquatic center for the community. The proposed site location for development would be the Wenatchi Landing area. Work has been done with the City of Wenatchee to remodel the Wenatchee pool, the grant funding was to refurbish the pool bottom to mitigate leaking, the bids received were exponentially higher than anticipated, the city will need to make a decision on remodeling. Discussion held on the aquatic center facility development, Senator Hawkins proposed establishing a metropolitan parks district however this is already in existence, the public facilities statue may be an alternate option. Senator Hawkins is looking to develop new legislation to allow for regional governments to consolidate resources and develop a 1/10th sales tax for a regional economic development driver for an event or facility center. This would establish a new Governing Board from the counties and cities who would be responsible for the direction of development for the aquatic center. Senator Hawkins believed development of the aquatic center at the Wenatchi Landing area could reignite the Regional Port's interest in the area.
- B. Commissioner Steinburg raised concerns regarding the development of self-sustaining facility and event sport center complex, promoting more economic growth and development. Commissioner Steinburg would also like the establishment of the regional center to occur by joint vote of both counties rather than populace base. Both Commissioner Straub and Steinburg raised concerns regarding not wanting to compete with private enterprise in developing a waterslide that could impact similar businesses like Slidewaters. The need for infrastructure will be vital to the success for the project.
- C. Senator Hawkins provided insight that the revenue stream would be similar to that of LINK Transit's 1/10th sales tax initiative.
- D. Douglas County will participate in the September 15th regional discussion with Senator Hawkins, the cities, counties, and Regional Port Authority to discuss options and infrastructure needs.

A. The automatic fee schedule increase states, rate increases above 5% requires Board of Commissioners authorization, outline of the proposed rate increase at 5% as well as 8%. The Board is in agreement for the increase at 8% as long as the deliverable services match the payment.
